In the matter of : S.L.P. (C) No. 10228/2022 titled as Vaid Shankar Lal Memorial College of Education Vs. State of H.P. & others.

The above titled S.L.P. was filed by the petitioner(s) against the judgement dated 06.04.2022 passed by the Hon'ble High Court in CWP No. 4113/2019, whereby the full bench of the Hon'ble High court declared that the law laid down in CWP No. 7688/2013, being in tune with the settled proposition of law on the subject, is correctly decided, whereby it was declared that the measures providing for admission to various courses on the basis of CET as imposed by the respondents are reasonable.

The S.L.P.(C) was listed before the Hon'ble Supreme Court on 22.07.2022 and on this day the Hon'ble Supreme Court dismissed the SLP and on the request of Ld. Counsel for the student passed the following order:

“The aforesaid matter falling within the policy domain, the students, if they so choose, may approach the State Government for reconsideration of the additional norms the State Government has prescribed, It is a call which the State Government has to take in that behalf.”

In pursuance to the directions issued by the Hon'ble Supreme Court, the matter was considered and it was decided that admissions to D.El.Ed. Course shall be through Common Entrance Test (CET) only in order to maintain the quality of education especially at the Primary stage i.e. Class 1 to 5, which is the prime concern of the State. The Common Entrance Test (CET) for D.El.Ed. training ensures transparent and competitive admission to the eligible candidates who score atleast the minimum qualifying marks in the test. Admissions in DIETs/ private Institutions imparting D.El.Ed. Training/Course of such CET qualified candidates ensures that they have atleast minimum knowledge of the basics of content, whereas direct admissions to any candidate for doing D.El.Ed. from any Pvt. Institution will lead to deterioration of minimum standards of quality education.

Hence, in view of above facts, the representation of the students is rejected and decided accordingly.


