Experience eligibility	At least 15 years of teaching experience in H.P. Government job (as JBT/TGT/Lecturer-School).

Weightage	Academics-40% Written Test and demonstration of teaching skills- 40% Interview-20%

**Notification**

The Governor, Himachal Pradesh is pleased to issue Policy Guidelines, 2023 for selection of Block Resource Centre Coordinators (BRCCs) under Samagra Shiksha in Himachal Pradesh as given below:

1	<b>Name of Post</b>	<b>Block Resource Centre Coordinators (BRCC)</b> The post will be a selection post.
2	<b>Number of Posts</b>	Two BRCCs to be appointed for one Education Block. One from JBT and one from Lecturer/TGT.
3	<b>Total posts within a District shall be filled up from the feeder cadres as follows:-</b>	a. 50% from the JBT cadre. b. 25% from the TGT cadre. c. 25% from the Lecturer (School) cadre.
4	<b>Eligibility Criteria</b>	a. The candidate should possess at least 15 years of teaching experience in Government job (as JBT/TGT/Lecturer-School). b. He/She should possess a Graduate degree from recognized university. c. There should not be any departmental enquiry or proceedings pending or contemplated against the applicant & he/she should not have been punished or held guilty for misconduct or for dereliction of duty by the department at any stage during his/her career. d. He/She should not be more than 50 years of age as on 1 <sup>st</sup> day of January of the year in which the selection is being made.
5	<b>Desirable Qualification:</b>	Knowledge of Computers and "Samagra Shiksha" Schemes.
6	<b>Tenure</b>	a. A BRCC shall be appointed for a period of 05 years. b. Once appointed, such person will not be eligible for another term as BRCC, even if he/she does not complete his/her tenure of 05 years on initial appointment. c. A person who has already worked as BRCC in the past,



will not be eligible for applying again to the post of BRCC.

- d. BRCC so appointed can be repatriated at any time in public interest or if the performance of the BRCC is not found satisfactory, or his/her working is not found in the interest of the project. The decision to repatriate the BRCC will be taken by the Secretary (Education) on the basis of a report of SPD (SSA).

7 **Selection Process:**

The selection of BRCCs shall be based on the following criteria:

1	Academics	(40%)
2	Written Test & Demonstration of Teaching Skills	(40%)
3	Interview	(20%)

The Details of the criteria are:-

1. **Academics:** - 40 % weightage in selection criteria will be given to the marks obtained by the candidate in his/her Graduation.
2. **Written Test & Demonstration of Teaching Skill:**  
- Criteria regarding written test & Demonstration of Teaching Skill will be prescribed separately.
3. **Interview:** - There shall be an interview carrying a weightage of 20% in the selection criteria.

**Formation of Interview Committee:**

The Interview will be conducted by a Committee consisting of following officers:-


1	Secretary/Special Secretary	Chairman
2	Director Higher Education	Member
3	Director Elementary Education	Member
4	State Project Director	Member Secretary

Based on the above selection process, the Committee shall recommend suitable candidates to the Director of Elementary/Higher Education, as applicable, for appointment as BRCCs on deputation basis.



- 8 Rest of the terms and conditions governing the appointments of BRCCs shall be issued by the State Project Director, Samagra Shiksha as per prevailing guidelines.


This notification shall come into effect from the date of its publication in official Gazette (e-gazette) of Himachal Pradesh.
