Minutes of the 209<sup>th</sup> PAB meeting held on 27<sup>th</sup> March, 2014 for approval of the Annual Work Plan & Budget of Sarva Shiksha Abhiyan (SSA), Himachal Pradesh.

- 1. The 209<sup>th</sup> meeting of the Project Approval Board for considering the Annual Work Plan and Budget (AWP&B) 2014-15 for SSA-RTE for the State of Himachal Pradesh was held on 27<sup>th</sup> March, 2014, under the Chairmanship of Sh. R. Bhattacharya, Secretary (SE&L).
- 2. A list of participants who attended the meeting is attached at *Annexure-I*.
- 3. The Fact Sheet of the State with educational indicators is attached at *Annexure-II*.
- 4. At the outset Secretary (SE&L) welcomed the participants and asked Director (MJ) to make a presentation on the Annual Work Plan & Budget of Sarva Shiksha Abhiyan (SSA), Himachal Pradesh which was followed by a discussion with Secretary Education, Himachal Pradesh, Shri Ali Raza Rizvi and the State Project Director, SSA alongwith his team. The following issues were flagged in the presentation
  - No information was shared by the State with regards to status of access in habitations with 40% SC or ST population or habitations with 70% population of SC/ST combined. The State promised to send this data at the earliest.
  - Number of Primary School has decreased. In 2011 there were 10713 PS and in 2014 the State is reporting 10650 PS despite opening of 94 PS in 2013-14. Hence, the total reduction is of 157 PS. This needs to be looked into by the State.
  - Admission to private schools under Section 12 of RTE has not started.
     State has also not factored in the availability of private schools for neighborhood access
  - The number of single teacher schools has increased as of last year, there are 26000 (4.23%) children enrolled in single teacher schools (1365), the State needs to redeploy teachers urgently. It was also pointed out that only 34% upper primary schools have subject teachers. It was informed by the State that new recruitment of teachers is taking place and progress will be informed in the next quarter.
  - The working hours for teachers reported by the state is 36 hrs per week which is below the RTE norms. This needs to be increased to 45 hours a week and the State assured that this would be done. State is yet to notify Minimum working hours per week and working days in a year for the teachers.
  - Overall Progress of civil works is slow

- Executive Council of SSA is headed by Secretary, Education, Himachal Pradesh in place of Chief Secretary, Himachal Pradesh. This needs to be rectified.
- 5. The AWP&B presented by the State was comprehensively appraised by the TSG and shared with the State in an Appraisal Note as well as in the PAB.

PAB also reviewed the progress against the targets set by the State in the Results Framework 2013-14. The Results Framework is attached at *Annexure III*.

## 6. Approvals -

The PAB discussed the State proposal for AWP&B for 2014-15. The points discussed and the decisions taken by the PAB together with intervention-wise outlay approved under SSA and KGBV are as follows:-

### 6.1 Access –

The state had proposed 68 primary and 77 upper primary schools for 2014-15. However habitaiton wise data indicates that in 23 habitaions primary school already exists within 1.5 KM which is the prescribed neighbourhood norm of the state RTE Rules. Moreover 27 habitations do not have requiste number of children (25 children) as prescribed in its RTE Rules. Only 18 schools were found fulfilling the distance and population (25 children) norms of the State. In view of the decreasing trend of enrollment and reducing size of schools, new primary schools were not approved. However

upgradation of 9 primary schools to upper primary schools was approved since only 9 schools proposed were found fulfilling the distance and population (25 children) norms of the state. Hence 3 classrooms each (total of 27 classrooms) for 9 schools alongwith teachers was approved. It was also assured that once the classrooms are ready TLE would also be given.

The PAB clarified that all children covered under Special Training must be first enrolled in the neighbourhood school and the school Head Master must supervise the STCs' periodically.

The detailed break-up of the unit cost of the Special Training Centres should be approved by the State Executive Committee of SSA. This amount to 0.42 % of the approved outlay.

### 6.2 Retention -

### 6.2.1 Free Textbooks (Rs.680.36) -

PAB noted that State has reported an expenditure of Rs. 1153.24 lakh under free textbooks against the PAB approval of Rs. 714.95 lakh during 2013-14. PAB express concerned that how can the norm based approval be violated. PAB desided that expenditure of Rs. 438.29 which is beyond PAB approved sanction can not be supported under SSA and State will have to bear it from its own budget.

PAB Approved an outlay of Rs. 680.36 lakh for Free textbooks as detailed below, for children not previously covered by the State: -

The PAB approved an outlay of **Rs. 1743.86 lakhs** for two sets of uniforms to all girls, SC and ST boys as detailed below. Uniforms to students to be provided @ Rs. 400/- were approved subject to strict adherence to the SSA guidelines which stipulate decentralized purchase & distribution of uniforms by the SMC's.

#### 6.2.4 KGBV -

The Action taken on the Report of the National Evaluation 2013 was also discussed. It had been pointed out by the team who had visited Himachal Pradesh that the KGBVs in Himachal Pradesh do not cater to out of school/never enrolled girls, but to SC, ST and BPL and identification of students is done in an ad-hoc manner. No enriched curriculum and supplementary reading materials/practices were found. Some KGBVs lacked basic infrastructural facilities like toilets and bathrooms. The practice of hiring male staff-especially accountant who stays in the KGBV from 9:00 AM to 5:00 PM every day, cook and remedial teachers needs to be regulated/discontinued. Convergence within SSA for academic support and with other departments like health and sanitation was found to be weak.

The State informed that in academic session 2014-15, selection of eligible girls for enrollment in KGBV is in process. Priority is being given to the girls who are Out of school- drop outs, from minority community, BPL and SC,ST,OBC. SMCs are being oriented for identification of the above group in all KGBVs. Enhancement in learning levels will be ensured through regular monitoring, CCE register and end line assessment. It is being ensured that girls should be given nutritive food and the issue of lack of infrastructural facilities is also being addressed. All the concerned DPOs have been directed to replace male staff and female staff be engaged in their place from 1<sup>st</sup> April, 2014 as they have been engaged upto 31<sup>st</sup> March, 14. Their contract will not be renewed after 31<sup>st</sup> March, 14. For the time being accountants have been given direction to sit in the office of Principal /BRCC of KGBV school and the male members will not be allowed to enter inside the KGBV hostel. The instructions have been made part of the guidelines.

### 6.3 Quality –

6.3.1 The State team presented a comprehensive plan for quality improvement. The State has conducted learning achievement studies for all students across all schools from class 2 onwards. This study was done on IRT methodology aswas shared by the State team. The detail class-wise results were shared by the State in their Annual Work Plan. The PAB appreciated the efforts made by the State and also recommended this to be documented by the TSG, SSA as a best practice on large scale assessments.

## 6.3.2 Focussed programme for classes 1 and 2: -

The PAB approved proposals of the State focussed on improving reading, writing and comprehension in class 1 and 2. Workbooks have been developed by SCERT and these are used by students. For this at a unit cost of Rs 40 per child for

127251 students was approved, totaling Rs. 50.90 lakhs. This cost is included within the SSA financial head of free textbooks within the cost norm of Rs 150 per child. The State has developed a teacher resource book which has been approved at a unit cost of Rs 25 per school for 10651school for which a budget of Rs 2.66 lakhs was approved under LEP. Teachers will receive training at block level for 5 days (residential @ Rs 200 per person per day). Rs 93.98 lakhs was approved for 9398 teachers(excluding teachers from single teacher schools). Follow up at cluster level for the same 9398 teachers was approved for 5 days at a unit cost of Rs100 per person per day with a budget of Rs.46.99 lakhs. Training of 496 RP's for 5 days of residential training with a budget of Rs.4.96 lakhs was also agreed to; the State committed to improving learning levels of students 75% students in class 2 will achieve learning standards of class 2 at the end of class 2. For this the State was approved an amount of Rs 5 lakhs under REMS for a sample survey. The findings of the learning assessment survey will be shared with the PAB 2015-16.

States' proposal for learning resources for each school @ Rs. 1000 was not approved as it mainly included stationery for schools.

### 6.3.3 Focussed programme for classes 3 to 5: -

PAB approved workbooks for students developed by SCERT for all subjects at a unit cost of Rs 40 per child for which a budget of Rs 93.52 lakhs is included within the cost of Free textbooks norm of Rs 150 per child. A teacher manual at a unit cost of Rs 20 per school for 10651 schools was approved under LEP for which the budget approved was Rs 2.13 lakhs. Training of 9398 teachers for 5 days of residential training at the block level was approved under teacher training for which the budget approved was Rs 93.98 lakhs. Follow up at cluster level for the same 9398 teachers at the cluster level was approved for 5 days for which Rs.46.99 lakhs was approved under teacher training. Training of 496 RP's for 5 days of residential training was approved by the PAB for which the budget was Rs 4.96 lakhs.

States proposal for learning resources for each school @ Rs. 1000 was not approved as it mainly included stationery for schools.

## 6.3.4 Focussed programme for classes 6 to 8: -

For a focussed programme for teaching- learning of maths and science in upper primary classes PAB approved workbooks for all subjects at a unit cost of Rs. 150 per student for 253241 students for which a budget of Rs. 379.86 lakhs was approved under LEP. In the State there are 4880 maths and science teachers. A 5 days residential training at the block level has approved for these teachers for which a budget of Rs.48.80 lakhs was approved under teacher training; follow up at the cluster level for these 4880 teachers was approved for 5 days for which a budget of Rs. 24.40 lakhs was approved under teacher training. Training of 248 Resource persons was approved for 5 days of residential training with a budget of Rs. 2.48 lakhs.

States proposal for training of language and social science teachers at the upper primary level was not approved as the primary focus in 2014-15 is to improve learning outcomes of students in maths and science.

**6.3.5** Refresher non-residential in-service training for 100 cluster head teachers for 10 days at BRC level was also approved.

# 6.4 Teachers' Salary (Rs. 10590.58) -

Teachers salary was approved for teachers in position. As and when teachers would be recruited including for the 9 upgraded UPS (2014-2015) and would take up their post the State could approach GOI for additional funds for salaries. There are 1344 vacancies (State) and 227 vacancies(SSA) which are likely to be filled up shortly by the State.

- (vii) The State committed to ensure that all child entitlements, including textbooks, supplementary material, uniforms, etc. are provided at the beginning of the academic year to all children.
- (viii) State committed to ensure that all school related grants under SSA, including School Grant and Maintenance Grant are released in the first quarter of the financial year to facilitate schools to utilise the Grants in a meaningful manner.
- (ix) To provide & maintain a budget head for the central share of SSA in the State Budget.
- (x) The first installment of the State share should be released to the State Society within one month of the release of Central share to the State Society.
